2018–2019 Data Trends (Highlights)

- Increase in student population to almost 1,000 students
- School-wide gain in English Language Arts (ELA)
- 7th Graders had an increase of 9% on the California Physical Fitness Test, 6% increase in Mathematics and 14% increase in English Language Arts.
- Even with an increase of students from the 2017-2018 school year to the 2018-2019 school year, there were significant decreases in A2A Truancy Rate (-13.02%) and A2A Chronic Rate(-26.68%)
- 100% pass rate on the Dual Immersion Spanish Placement Test

76% passed the written section with a perfect score of 5 (60% in 2017-2018)

12% passed the written section with a score of 4

12% passes the written section with a score of 3

Oral Presentation (must earn a 2 to pass)

25% earned a score of 5

2018-2019 Data Analysis and Conclusions

- Continue to focus on the California Physical Fitness Exam scores. Staff will work with the new elementary Physical Education Teacher on Special Assignment to continue to build our PE program in Kinder- 5th
- Continued focus on the area of Mathematics. Junction teachers have committed to working though out the year with LVJUSD Mathematics teaching and learning plan.

 Although Junction increased in all student performance group areas, there is still room for growth. Junction will continue Title One Reading Intervention to help close the achievement gap.

2019-2020 LCAP Site Goals

- The percentage of students scoring "Standard Met or Standard Exceeded" on the California Assessment of Student Performance and Progress (CAASPP) will increase by 5% overall with English Learner students increasing by 5% and SED/SWD students increasing by 5%
- The percentage of students scoring "Standards Met or Exceeded" on the CAASPP will increase. All significant subgroups will increase 5% overall with English Learners increasing by 5% and SED/SWD students increasing by 5%
- The writing claim in the CAASPP will improve school-wide by 5%
- Maintain or decrease suspensions by using positive discipline or alternatives to suspensions such as "Friday School Intervention"
- Maintain our Associated Student Body Leadership classes and Positive Behavior Intervention Supports (PBIS) and incentives

- Increase the percentage of students scoring 5/6 or 6/6 on the California Physical Fitness components in 2017-2018 by 5%
