# **Adopted Meeting Minutes**

#### 1.0 Call to Order

#### 3.0 Minutes

**3.1** Approval of the February 9, 2022 Meeting Minutes. There was a motion to approve the minutes by by Yalon, seconded by Durban. Roll call was taken, 8 Ayes, 0 Nayes, 1 Abstention approved the minutes.

  - reorganize the list of projects from largest to smallest expenses.

Staff will prepare the amended annual report and provide to the Chair for confirmation of changes. Bailey motioned to approve the CBOC Report for the Fiscal Year 2020/2021 as amended. Macedo seconded the motion. The motion passed unanimously.

#### **6.2** General Committee Discussion:

- The committee noted Measure J funding is coming to an end, and District facility needs continue.
- Removal of portables reduces maintenance cost

- The committee asked for estimated state funding eligibility. Staff replied that estimated District eligibility is \$27M.
- The committee asked for more information on the FMP. Staff shared this will be reviewed at the June 2022 meeting
