Affidavit for Parent and Child Sharing a Residence With Another Adult

The affidavit is used only to assure the District that you reside within the attendance area of the Livermore Valley Joint Unified School District and/or the school attendance area in which you wish to enroll. The affidavit of residence requires that:

- 1. The student and the parent/guardian live at this address seven (7) days a week. The Child Welfare and Attendance Specialist may make periodic checks to determine that the student continues to reside with the parent/guardian at the address listed below.
- 2. Any change of address will revoke this permit.
- 3. The permit will need to be renewed during transition (when changing schools).
- 4. The affidavit will be revoked if any information herein has been falsified.
- 5. Do NOT sign this form if any of the statements below are incorrect or you will be committing a crime punishable by a fine, imprisonment or both.
