### Parent and Student Acknowledgement of Safe and Sober Grad Night Policies

#### Alcohol, Drug and Tobacco-Free Event

In alignment with Livermore Valley Joint Unified School District (LVJUSD) Board Policy BP 3513.3(a), "The Board prohibits the use of any tobacco products at any time in District-owned or leased buildings, on District property and in District vehicles" and LVJUSD Board Policy BP 5145.12, "The Board recognizes the significant risk to students, staff, and the community at large whenever students use alcohol on school property or at school-sponsored events. In order to prevent the use of alcohol at school or school-sponsored events, the school officials are authorized to conduct random or suspicionless tests using breathalyzers, or other devices, which have an established scientific basis for accuracy," students will be subject to breathalyzer screening upon entry. In addition to the enforcement of these policies, alcohol, vaping, ecigarettes, illegal substances, or other products of this nature are not permitted at the Safe & Sober Grad Night event.

Students testing positive for alcohol or found with such items on their person will not be allowed entrance and a parent/guardian will be called to pick up the student. Every student must have a Parent and Student Acknowledgement of Safe and Sober Grad Night Policies form signed. This is a drug, alcohol, and vape free environment. Every student in attendance, will be breathalyzed and any student who is found to be under the influence of drugs, alcohol, or have vaping, electronic cigarettes or other vaping products on his/her person will be refused entry. **Ticket prices will NOT be refunded, and a parent or guardian will be called to take the student home.** 

#### **Attendance**

Graduating seniors from Granada High School or Livermore High School may attend their own Safe and Sober Grad Night event. Graduating seniors in attendance at Vineyard Alternative school, who are in good standing, may attend the Safe and Sober Grad Night of their "home" school. Ticket purchase and all corresponding paperwork is required. Any senior who is removed from graduation ceremonies will NOT be allowed to attend Safe and Sober Grad Night. Their ticket price will NOT be refunded. Scholarships are available for graduates who are unable to afford the ticket purchase price. Please see the VP in charge of seniors at the school site.

#### Check In/Out

Doors open for check in at 10pm and close at 11:30pm. Students are expected to stay for the duration of the event, which ends at 5AM the following morning. Students who wish to leave early must have verbal permission via phone call with a parent/guardian from the event using the parent/guardian contact phone number provided on ticket purchase paperwork. ALL graduates in attendance are checked in and out by a Safe and Sober Grad Night volunteer (Student Resource Officer, citizen policy academy volunteer, parent volunteer, or campus supervisor).

#### Dress Code/Behavior

This is a fun and causal event, but Livermore Valley Joint Unified School District Dress Code will be followed. Please consider bringing a sweatshirt or jacket as the event is both indoors and outdoors. A coat check is available for each graduate to store items. However, the Safe and Sober Grad Night committee is not responsible for lost or stolen items.

Proper behavior is expected. Unruly students will be isolated until a parent/guardian arrives to take the student home. Use or possession of alcohol, drugs, drug paraphernalia, or weapons will not be tolerated. Parents/guardians and police will be immediately notified. Smoking, tobacco products, vaping products, or outside food and beverages are not permitted.

#### **Ticket Refunds**

Please check your school's Safe & Sober Grad Night website to see if you've already purchased a ticket if you are unsure. This prevents the committee from processing unnecessary refunds. Refunds are available until May 31st. After this date, any graduate who has purchased a ticket and decides not to attend or if a duplicate ticket is purchased the ticket price will be forfeit. If an exception to this policy is required, please speak with the Grad Night Chair(s). These are evaluated on a case-by-case basis and not guaranteed.

#### Ticket Sales

Each school has discretion to offer SSGN tickets at a price point that drives early or promotional purchases to enable them to meet their fundraising goals. Revenue from these ticket sales are used to place deposits on entertainment, finalize payment to vendors, purchase food and non-alcoholic beverages, and purchase prizes for the event. Ticket sales at the door are CASH-ONLY.
